The CMG Strategic Aggressive Portfolio provides a diversified core portfolio designed to be in line with a 90/10 stock/bond asset allocation. The target risk profile of the composite is to be above a 16% annual standard deviation. The portfolio is rebalanced annually.

The benchmark for the composite is the Aggressive Allocation Benchmark. It is a custom benchmark that is rebalanced annually. The underlying components of the benchmark and their respective static allocations are: 64% S&P 500 Total Return, 26% FTSE World Ex US Total Return, 5% ICE BofA Current 5 Year US Treasury, and 5% FTSE World Government Bond Index Non USD. The minimum account size for this composite is \$5,000. The CMG Strategic Aggressive Portfolio Composite was created July 1, 2020 and its inception date is December 2019.

The U.S. Dollar is the currency used to express performance. Returns are presented gross and net of fees and include the reinvestment of all income. Net returns are reduced by all management and custodial fees. Net returns are calculated by reducing gross returns by a model fee applied quarterly using 1/4th of the highest fee. Accounts pay a fee based on a percentage of assets under management. This fee includes investment management, portfolio monitoring, consulting services, and in some cases, custodial services. The annual composite dispersion presented is an asset-weighted standard deviation calculated for the accounts in the composite the entire year.
